Derry Borough Council met in regular session Tuesday, July 1, 2025 at 7:02pm at AV Germano Hall, 100 W. Second Street, Derry, PA with the following members present: Barbara Phillips, Rob White, Nathan Bundy, Jasen Lentz, Sara Cowan, and Jim Ritenour. Rich Eikenburg was absent. SPECIAL BUSINESS

1. Discussion held to weigh the decision of modifying or closing for the remainder of the season for the Derry Community Pool. Based on the recommendation of the Lifeguard Assistant Manager, council agreed to close the pool on Mondays to aid in the short staff issue.
2. **MOTION** by Jim Ritenour to approve adjusting pool staff wages based on the matrix provided by Nathan Bundy as well as including a retroactive pay increase for employee's hours worked from the beginning of the season. Motion **SECONDED** by Sara Cowan. All members present voiced "aye" in favor of the motion. Motion passed.
3. **MOTION** by Nathan Bundy to approve refunding season pass holders or offer a 10% discount on other purchases throughout the rest of the season for those passholders that do not wish to take the refund. Motion **SECONDED** by Rob White. All members present voiced "aye" in favor of the motion. Motion passed.
4. **MOTION** by Nathan Bundy to approve reimbursing the current lifeguards for their certifications at the end of the pool season with presentation of the lifeguard's receipts. Motion **SECONDED** by Sara Cowan. All members present voiced "aye" in favor of the motion. Motion passed.
5. **MOTION** by Jasen Lentz to approve a fundraiser ran by Friends of Derry to be held at the Derry Community Pool with all proceeds benefiting the pool's various needs. Motion **SECONDED** by Rob White. All members present voiced "aye" in favor of the motion. Motion passed.
6. **MOTION** by Nathan Bundy to approve Resolution 693-25 for applying for the DOJ- COPS Grant. Motion **SECONDED** by Sara Cowan. All members present voiced "aye" in favor of the motion. Motion passed.
